Safety Statement	Corris Caverns Ltd, are the owner and operators of King Arthur's Labyrinth and Welsh Legends Maze. Corris Caverns Ltd are owners of the Corris Craft Centre. Corris Caverns Ltd fully accepts its responsibilities under Health and Safety Legislation. A Health and Safety Policy is in place together with written risk assessments undertaken in respect of our legal duties relating to persons other than employees (i.e. visitors) coming onto our site and using our facilities. Your safety and health whilst at King Arthur's Labyrinth, Welsh Legends Maze and Corris Craft Centre is of utmost concern to us. We have worked closely with the Health and Safety Executive and Local Authority regarding health and safety matters and want to ensure that your visit is a fun, enjoyable and learning experience. King Arthur's Labyrinth is inspected and accredited annually by Visit Wales under the Visitor Attractions Quality Assurance Scheme. We operate a policy for staff recruitment, training and assessment which ensures that all staff with a responsibility for the safety and welfare of visitors are qualified to undertake the duties they are assigned Schools are informed of the following details which will aid the undertaking of their own school 'educational visit' risk assessment for the purposes of their visit. Background	
Experience	Corris Craft Centre has been open since the early 1980s and King Arthur's Labyrinth was opened to the public in 1994.
Venue Details	King Arthur's Labyrinth takes visitors on an exciting underground journey by boat and foot into tunnels and caverns of the original working slate mine. Traditional Welsh legends from the Mabinogion and other sources are told using tableaux, light and sound. A further attraction, the Welsh Legends Maze is above ground and visitors are invited to search for the "lost legends" and listen to them. The Maze is on level ground with access along gravel paths. The Craft Centre has a range of craft workshops which are leased by independent craft producers who manufacture and sell their goods at Corris. There is a café serving hot and cold food and drink. Packed lunches can be ordered for your group. Please ask for details during your booking process. The reception and shop for King Arthur's Labyrinth is also based within the Craft Centre. In the grounds of the Craft Centre there is a small children's play area most suitable for primary school age.
Visitor Numbers	Annually we receive approximately 80,000 visitors to the Corris Craft Centre and, of these, around 35,000 visit King Arthur's Labyrinth and over 30 school visits
Suitability	King Arthur's Labyrinth and its attractions are considered suitable for pupils of all ages and abilities.

General Information

Animal Fouling in Public Access areas	Dogs are allowed entry into the grounds of Corris Craft Centre but must be kept on a lead at all times. Access by dogs into the individual craft workshops is at the absolute discretion of the craft worker themselves. No dogs, other than guide dogs, are allowed into the children's play area or the underground tour of King Arthur's Labyrinth. Guide dog owners are asked to discuss the conditions with reception staff to establish that it is suitable for their dog. Owners must clean up any animal fouling and place this safely in the bins provided.
Communication Systems	Departments are linked by telephone and the staff operating the underground tours are linked with a radio system.
Criminal History / Civil Actions	All reasonable measures are taken to ensure that staff are of good character and have no record of criminal or civil actions which would indicate that they are a threat in any way to our visitors.
Equipment / Play Equipment	All equipment is regularly checked to ensure it remains 'fit for purpose' and results of inspections are recorded. School staff must supervise children when using this equipment. The climbing of trees within the venue is forbidden. The play area is a dog and smoke free area.
Emergency Evacuation	Emergency evacuation procedures are in place for the underground attraction. All King Arthur's Labyrinth staff are familiar with and practice these procedures. Emergency exits are clearly identified in the reception, workshops and other buildings and notices are posted around the site and by each fire exit and fire extinguisher. In the event of emergency evacuation, staff will instruct the public to assemble at our evacuation point in the main Car park. Full guidance will be provided. In the event of a Major Emergency a plan is in place and has been shared with the Emergency Services.
Facilities for visitors with Special Needs	King Arthur's Labyrinth and Corris Craft Centre try to accommodate the requirements of visitors with special needs. Schools and party leaders must ensure that suitable arrangements are in place in order that appropriate supervision and assistance is available to pupils with special needs. <u>Physical Impairment</u> – Wheelchair access is possible throughout the Craft Centre and maze. Accommodating wheelchairs in King Arthur's Labyrinth underground tour is not possible due to the nature of the emergency exit which, in the unlikely event of it being used, requires the ascent of a long stone staircase. <u>Visual Impairment</u> – The edges of steps within the venue have been made more conspicuous. The underground tour is dimly lit but the walkways are clear, level and lit. We are aware that clarification of specific provisions may be needed by schools in relation to more detailed risk assessment requirements for certain special needs pupils. In such circumstances we would invite schools to contact us.

Special Needs	
First Aid	First aid provision is to HSE standard throughout our attractions. First Aid points are: King Arthur's Labyrinth reception, Café (inc Burns Kit) and Welsh Deli. There are full first aid provisions underground. At least one qualified First Aider is always on shift. Corris Caverns also possesses a Defib machine. There are also provisions for bug stings available in the café.
Guided Tours	The visits into the Labyrinth are always in guided groups. School groups should always have a member of staff with each group. There are no guided tours of the Craft Centre but information and guidance can always be provided by the reception staff or in advance of your visit. By its nature, there are no guides in the maze.
Height Restrictions	There are no height restrictions but tall people should be aware that some areas of the Labyrinth are low. Helmets are provided to all visitors which must be worn at all times when underground. The tunnels are on average 6ft high with one small tunnel being c.4ft high.
Insurance (Public Liability)	We have a public liability insurance cover of £8million A copy of our insurance certificate can be provided to visiting parties prior to their arrival on request.
Loss of Bearings	Please note that due to the extent of the Craft Centre grounds children are at a small risk of getting lost if they stray from organised parties. It is important that people in groups underground should stay together. However, there are provisions in place to ensure that people cannot wander far in the extensive underground workings and guides keep a close check on the members of their group at all times.
Lost Person Stations	The Labyrinth reception is the designated lost person station. We ask that all group organisers discuss this with the party and point out this station upon arrival.
Medical Needs	King Arthur's Labyrinth should be contacted by the school or party leader before their visit if any pupil is known to have any specific or serious medical condition / need. Discussion will be needed to consider emergency arrangements. We will, where it is safe to do so, aim to fully include pupils with specific or serious medical conditions within activities offered.
Harmful / Poisonous Plants / Fungi (<i>Mushrooms & toadstools</i>)	At certain times of the year some poisonous berries may grow on trees and shrubs within the grounds. Schools should advise all children that berries should not be touched, picked or eaten. If you do suspect that someone has ingested a poisonous berry etc then they are to be taken to the hospital in Aberystwyth immediately. Certain fungi (<i>mushrooms & toadstools</i>) are also known to grow periodically. Schools should advise all children that any fungi should not be touched, picked or eaten.

Required Visitor Conduct (no access to areas for site staff only)	Visitors must not -enter areas which are <u>not</u> open to the public -behave in an unruly manner -touch any working machinery -ignore the instructions of the guide (where provided) or the craft person in the craft workshops - Any one under the influence of alcohol or drugs and causing distress will be asked to leave the site immediately. Party leaders must not leave children unsupervised; we allow one free place per 10 paying children to assist with this.
Site Inspections of Venue Facilities / Areas	Staff conduct regular inspections of the facilities and an internal reporting mechanism is in place for any safety hazards. The underground workings and play area is also inspected annually by a qualified 3 rd party.
Site Staff Identification	Staff wear a clearly identifiable uniform and can be approached at any time. Black T-Shirt with the Corris Caverns Logo and "CREW"
Vehicle Traffic	The main site is a pedestrian area but it is not enclosed securely and party leaders should ensure that unsupervised children do not stray into the car park areas or on to the access road. A Visitor Coach Park is available. Corris Caverns is next to the busy A487, the site is secured by a fence but children should be supervised at all times.
Weather Protection / Sun Safety	The Craft Centre workshops, café and the King Arthur's Labyrinth reception offer covered areas in case of inclement weather. The underground Labyrinth also provides protection but it is necessary to approach the Labyrinth entrance through the open air. The Labyrinth is a constant temperature of 8°C, therefore any visitors are asked to dress appropriately with warm clothing and sensible footwear. The maze is in the open air. We advise that party leaders ensure that all have warm clothing, waterproofs and sensible footwear.
Welfare Facilities	Three public toilet blocks are present within the Craft Centre. One female, one male and a high dependency room (RADAR). All public conveniences are regularly checked and cleaned by staff but visitors are urged to report anything that needs attention immediately to the reception or the café. Both male and female toilets have baby changing facilities. The Craft Centre also has a high dependency disabled unisex toilet unit accessible by RADAR key. A key can be loaned from the Café. The cafe within the venue offers a selection of light meals, snacks and drinks. Water is freely available.

Safety Equipment / Clothing	Visitors to King Arthur's Labyrinth are issued with helmets which must be worn at all times when underground. Visitors are advised to wear warm clothing for the underground visit as the temperature is always cool whatever the weather on the surface. "Sensible" shoes are strongly recommended for the underground tour.
Underground Activities	Visitors to King Arthur's Labyrinth are taken into the workings of a former slate mine which are now used as a theatrical space to tell stories using 'son et lumiere' techniques. The visit starts and ends with a voyage on an underground boat along an underground river. The boat carries up to 20 visitors. It is solidly constructed of steel plate and is heavily ballasted to make it very stable. It is driven by 24 volt electric motors powered by sealed batteries. Visitors go underground in groups accompanied by a guide who is experienced in operating the equipment and driving the boat. Guides are fully trained in emergency procedures and are in contact with other staff at all times through a radio system. There is a backup generator in case of a power failure. Natural ventilation is good and tests have shown that there is no danger from radon or other noxious gases. In the unlikely event of something happening that prevents egress through the normal route, there is an emergency exit. This is well lit and people will be led out of the Labyrinth in small groups by the guides. Directions will be given by the staff- no customer or group will be left unattended at any time.
Water Courses & Ponds	The underground river is a maximum of 1.5 m deep but there is no easy access to it by the public who travel along it in a high sided boat in the company of the guide. There is virtually no current in the underground river. There are three underground lakes, all of which are fenced off and secured. These are deep and climbing on the fences around them is absolutely forbidden. Emergency buoyancy aids are available by each of the lakes. The maze has a shallow artificial stream and two ponds. The

	stream and one of the ponds are not fenced, therefore children should be supervised at all times.

Other Relevant Information

The craft workshops at Corris Craft Centre are operated as separate businesses by the individual craftspeople. Their retail areas have no specific hazards identified in their "visitor areas".

Demonstrations of the crafts are undertaken in areas which can be viewed from the retail area but not accessed.
